



**CORRECTED date for the AR Meeting!**

Today is Monday, April 13, 2020! There are few things I would like to share that have been asked by various members. You will receive another message from me this week.

- **Teachers need to be in contact with their students are families. The question is how often.**

Secondary was asked to provide one learning opportunity a week, have students submit work, provide feedback (not grade) and provide other engagement opportunities for students. Elementary were asked to provide multiple avenues for student/parent engagement per week (this could be daily as I am not finding the most recent communication). Both can be a mixture of verbal and email. As we need to track and understand our engagement levels this is being documented in a variety of ways depending on curriculum and building and the request of using a log to track the frequency of contact for students is appropriate (much like tracking data in the classroom).

It is highly recommended that you document/log your attempts to connect with your students and families.

- **Principals are asking to be added the teachers Remind, Class Dojo or other methods being used.**

Yes, this is requested in part to protect the teacher from allegations of inappropriate use.

- **What about username and password being shared with Administration, EC or other staff?**

This is a requirement of Board Policy 4040. Any teacher account used to provide educational materials, information or feedback to students is considered a district account and per policy the district can require the sharing of the username and password. This is required in the event of an emergency, the sudden departure of a staff member, or other concerns that require the district to access the account to communicate with students/families or review prior communications.

- **What about the Personal Days that have not been used what happens to them?**

Unused personal days will be paid out after the conclusion of the calendar year at the rate of \$150 per day.
