The Omaha Education Association Children's Action Fund (OEA CAF) uses <u>voluntary contributions</u> from OEA members for political purposes, including, but not limited to, making contributions and expenditures on behalf of friends of public education.

The OEA CAF Board works on your behalf in a number of ways. Through PACE, the OEA Political Action Committee for Education, we keep track of bills that come before our State Legislature. We communicate with members of the legislature on our positions and review legislative actions so we can determine whether a legislative member is a friend of education. Another role of the PACE Committee is to interview prospective candidates for School Board and State Legislature. Interviews are held and then recommendations are made. OEA CAF members chair the interview committees and serve on the interview teams. The OEA CAF Board also has the power to authorize contributions to candidates who are recommended. Contributions from OEA members makes all this possible. We encourage you to join the OEA PACE Committee and participate in this critical work!

**So, what can you do?** You can commit to making a contribution to OEA CAF. If you already contribute, consider increasing your current contribution. Think about it, if you are contributing only \$15 per year, that's 4 cents per day. Is contributing 4¢ per day commensurate with how passionate you are about public education? We can do something to shape the future of public education, but we need to <u>*do*</u> something – take action – we can't afford to wait for it to happen. Remember the quote — *"Life is 10% what happens to you and 90% how you react to it."*

## OEA CAF

The OEA Children's Action Fund (OEA CAF) collects voluntary contributions from OEA members and uses these contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of candidates who are friends of public education. Contributions to OEA Children's Action Fund are voluntary; making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. The OEA Children's Action Fund requires a deduction minimum <u>annual contribution</u> of \$15. A member may contribute more than the minimum amount, or may contribute nothing at all, without it affecting his or her membership status, rights, or benefits in OEA/NSEA/NEA.

Contributions or gifts to OEA Children's Action Fund are not deductible as charitable contributions for federal or state income tax purposes. OEA CAF follows the guidelines set forth in The Nebraska Political Accountability and Disclosure Act (the NPADA) (§§49-1401 et seq, Nebraska Revised Statutes) which regulates the financial activities of state political action committees (PACs) in Nebraska.
