April 15th at 5:00p.m. is the statutory deadline to submit your resignation to OPS. If you do not submit your resignation you will be employed by OPS for the 2021-2022 academic year.

May 1st retirees <u>must</u> notify the district how they want their insurance paid out.

Join the Retired organizations: Stay involved-and SAVE money!

Member organizations (like OEA/NSEA/NEA) monitor many issues that impact educators, and advocate for those issues in various forums (state and national legislatures, and state and local school boards). The true power of organizations is in their membership – the more members, the more power!

In retirement, you can continue to impact the issues important to educators by becoming a member of the retired organizations, OEA-Retired, NSEA-Retired, and NEA-Retired. In fact, you can join the retired organizations right now! You don't have to be retired to become a life-member of the retired organizations. You can become a preretired lifetime member at any time during your career. You can also join at the time you retire as a life member, but right now is the best time. Why? Because NSEA-Retired is offering a \$75 rebate of your lifetime dues if you join before June 1, 2021!



To qualify for the dues rebate, you must become a pre-retired lifetime member of all three organizations (OEA-Retired, NSEA-Retired, and NEA-Retired). As is the case with active membership in the organizations, retired membership is unified for all three organizations. The total lifetime dues for all three organizations right now is \$600 (\$100 for OEA-Retired, \$200 for NSEA-Retired, and \$300 for NEA-Retired). Annual dues (which are only available after you retire) for all three organizations are \$70. If you do the math, lifetime dues are a bargain if you live for more than 9 years in retirement!

Besides supporting organizations that advocate for your issues, retired members have opportunities to stay involved. Retired members elect delegates to both NSEA Delegate Assembly and NEA Representative Assembly, as well as leaders for the various organizations themselves. NSEA-Retired holds two conferences every year, conducts a Lobby Day in Lincoln to interact with State Senators, and sends members three newsletters each year. There are also newsletters for OEA-Retired and NEA-Retired, and all retirees continue to receive the NSEA Voice magazine. Retired members who substitute during retirement have the same liability insurance that they had as an active member.

Retired membership also brings all of the benefits provided by NEA Member Benefits – including access to cashrewards credit cards; travel programs; and various insurance products. Complete details about NEA Member Benefits can be found on their website, www.neaMB.com. NSEA-Retired manages Educators' Medicare Supplement, a Medicare supplement that continues the kind of health insurance benefit active members have with EHA; the supplement is for retirees who are Medicare eligible. Educators' Medicare Supplement offers dental coverage that is the same dental insurance you have as an EHA subscriber as an active teacher. The supplement is not available to the general public – only individuals who are insured by EHA when they turn 65, or who are members (or spouses) of NSEA-Retired have access to the insurance policy.

You can become a lifetime member of the retired organizations by going to the NSEA-Retired website, www.nsea. org/retired, and clicking on the JOIN NOW link and filling out the form. You can also call Rebecca Smith at NSEA, 1-800-742-0047, to request a paper application. Your \$75 rebate will be mailed to you when your lifetime dues have been fully paid.

- Enrichment/Project Based Learning will be in the afternoon Developed by building staff/teams

The summer school hourly rate is negotiated in our master agreement which is \$28.50/hourly. The OEA put forth an MOU to increase that rate but the district declined to entertain it. We are working on getting this addressed to increase the funds going into your pockets.

The Next Level Learning Summer 2021 is anticipating high student numbers; the district is needing an increase in the number of teachers. If you are interested in applying, please go to the internal application and log into your profile and complete the needed form to be considered.
