Blue Cross/Blue Shield

You may have received an email from Blue Cross/Blue Shield regarding a recent settlement and you were provided a unique ID. In that email it shared steps that you can go through to determine if it affected your rights.

What is the lawsuit about?

Plaintiffs claim that the Blue Cross Blue Shield Association and Settling Individual Blue Plans (collectively, “Settling Defendants”) violated antitrust laws by entering into an agreement not to compete with each other and to limit competition among themselves in selling health insurance and administrative services for health insurance
