2022/2023 EHA RATES

The EHA Board of Directors has announced the following rate and benefit change decisions for the 2022-23 contract year effective September 1, 2022.

The medical rates for all Active Employee plans will increase by 6.14%. The medical rates for all Early Retiree plans will increase by 6.14%. The dental rates for all participants will increase by 0.00%.

The overall increase for medical and dental coverage combined is 5.84%.
