



New Regulations On Charters from Department of Education

- The Federal Charter School Program is the single largest funder of charter schools in the country
- The US Dept. of Education has just proposed new regulations that would severely limit for-profit charters and abuse in the system
- The pro-privatization movement is flooding the DoEd with thousands of comments opposing this commonsense regulation

We and our allies have until Wednesday April 13th to submit comments supporting the proposals - and urging them to go further

- We need your help in generating comments. Ask each of your local presidents to submit. Ask your members, your friends and your community allies.

 Submitters are encouraged to customize their comments, especially with information about local charter schools and the impact on the community and our public schools.

DETAILS:

- Most importantly, the proposed regulations would:
- Prohibit for-profit operators from

getting federal grants to open charter schools

- Require that all applicants submit a "Community Impact Analysis" on the impact of opening a new charter on existing public schools; including whether additional student seats are needed, or whether there is under-utilized capacity in existing public schools.
- These two requirements would significantly restrict the abuse, waste, and profiteering that is rampant in the current Federal Charter School program.

Additionally, we are advocating that the proposals go further in order to

- Require that all federally funded charters comply with state Open Meeting and Freedom of Information laws
- Require that all federally funded charters employ only certificated educators
