Parent-Teacher Conferences: This week is the start of the parent-teacher conference season. Here is the language from our Master Agreement (p. 29):

Bargaining unit members may be required to attend two to four parent/teacher conference sessions per year. A session may occur over multiple days...These scheduled conferences can occur before, during or after the duty day. Bargaining unit members will receive compensatory time for each hour worked outside of the duty day up to a maximum of seven hours. Bargaining unit members shall be paid \$28.50 per hour for scheduled parent teacher conferences in excess of seven hours outside of the duty day per semester.

AR Meeting and General Assembly: The next Association Representative Assembly will be held Tuesday, October 11, 2022, at the IBEW Local #22, 8946 L St, Omaha, NE 68127. The meeting is open to all members of the Omaha Education Association. The meeting begins at 4:30 with secondary concerns followed by the general meeting and then closing with elementary concerns. It is also an opportunity to meet with some OEA and NSEA endorsed political candidates. Candidates for the Omaha Public Schools School Board, Bri Full, Margo Juarez, and Hina Agarwal, will be in attendance.

Extra Duty: Many of you have put in extra hours beyond your duty day. Please keep track of the time you spend beyond that duty day working on school "things" while still at school. Request an extra duty pay sheet from the office, record your hours, keep a copy for yourself, and **send** it to your administrator for compensation.

As the days get shorter and the temperatures get colder, remember to always take time for yourself. You cannot be the best teacher for your students when you are not being the best for you. You, as educators, are always putting the needs of others before your own. Please take time to be involved in the lives of your own families and children, do the things you enjoy, eat dessert first and go to bed when you are tired. I want you to know that I am working diligently for you to bring systemic change. Educators, I hear your stories and feel your discomfort, discouragement, joy, and elation. Thank you for all you have done, are doing, and will continue to do.
